Finance, Donald G. Rockwell, Chairperson

FY2013 Financial and Investment Update

Mr. Rockwell presented the Board with a FY 2013 Financial and Investment update.

Mr. Rockwell informed the Board that as of November 20, 2013, 71% of the SBM members have paid their bar dues and 36% of those members paid on-line.

Mr. Rockwell asked Mr. Horsch to provide the Board with the annual report of the SBM finances. Mr. Horsch provided a power point presentation on this issue.

Audit Committee, Donald G. Rockwell, Chairperson

Mr. Rockwell informed the Board that the Audit Committee met by conference call on November 15. He provided the Board with an update on the State Bar's ongoing audit.

Mr. Nolan reported that the committee approved the Client Protection Fund Claims and the District Character and Fitness Committee Appointments at its meeting this morning.

Ms Buiteweg presented the Board with the event summary for the 2013 State Bar Annual Meeting.

Court Rules

ADM File No. 2013-28 Proposed Amendment of Rule 2.510 of the Michigan Court Rules

The proposed amendments of MCR 2.510 would allow courts to authorize prospective jurors to complete and return questionnaires electronically, and would allow courts to create and maintain them electronically (i.e., in any medium authorized by court rules pursuant to MCR 1.109). The proposed change also would delete language in MCR 2.501(D) to clarify that the chief judge is responsible for initiation of the court's policies for summoning prospective jurors.

A motion was offered and seconded to support the proposed amendment with the amendment that the word "completed" in (C)(3) be changed to "returned" in order to match the language of (c)(1). The motion was approved.

Legislation

H.R. 2509 and S.B. 1224: Civil Justice Tax Fairness Act of 2013

These two identical bills amend the Internal Revenue Code to allow: (1) an exclusion from gross income for amounts received (whether by judgment or settlement, as lump sums or periodic payments) on account of a claim of unlawful discrimination; (2) income averaging for backpay and frontpay amounts received from such claims; and (3) an exemption from the alternative minimum tax (AMT) for any tax benefit resulting from the income averaging of amounts received from an unlawful discrimination claim.

The committee recommends that this legislation be deferred until the January meeting to allow for further Keller analysis.

Criminal Expunction

HB 5018 (Leonard) Criminal procedure; expunction; requirement for attorney general review of a set-aside application; eliminate. Amends sec. 1 of 1965 PA 213 (MCL 780.621).

HB 5019 (Johnson, J.) Juveniles; criminal procedure; requirement for attorney general review of a set-aside application; eliminate. Amends sec. 18e, ch. XIIA of 1939 PA 288 (MCL 712A.18e).

The committee recommends that this legislation be deferred until the January meeting for further research into the Attorney General's position on this matter.

SB 0518 (Proos) Traffic control; traffic regulation; use of vehicle boots for failure to satisfy certain court obligations; allow. Amends sec. 4803 of 1961 PA 236 (MCL 600.4803).

A motion was offered and seconded to oppose this legislation. The motion was approved.

Discussion

SB 0652/PA 164 (Jones) Courts; judges; court of claims; provide for certain number of court of appeals judges to serve as court of claims judges, and expand jurisdiction. Amends secs. 308, 841, 6404, 6407, 6410, 6413, 6419, 6421 & 8304 of 1961 PA 236 (MCL 600.308 et seq.) & repeals sec. 6419a of 1961 PA 236 (MCL 600.6419a).

The committee recognized that this legislation has already been signed by the Governor and did not take any action.

HB 5156 (Shirkey) Courts; judges; court of claims exceptions to trial by court without jury; provide for under certain circumstances. Amends sec. 6421 of 1961 PA 236 (MCL 600.6421).

A motion was offered and seconded to discuss the legislation at the December 2, 2013 meeting. The motion was approved.

HB 5153 (Walsh) Courts; judges; salary formula for judges; modify. Amends secs. 304, 555, 821& 8202 of 1961 PA 236 (MCL 600.304 et seq.).

A motion was offered and seconded to discuss the legislation at the December 2, 2013 meeting. The motion was approved.

HB 5154 (Leonard) Criminal procedure; preliminary examination; certain rules and procedures for conducting a preliminary examination; revise. Amends secs. 4, 7, 11a, 11b & 13, ch. VI of 1927 PA 175 (MCL 766.4 et seq.). HB 5155 (Walsh) Courts; district court; probable cause conferences in felony and misdemeanor cases; clarify district court's jurisdiction. Amends secs. 8311 & 8511 of 1961 PA 236 (MCL 600.8311 & 600.8511) & repeals sec. 2167 of 1961 PA 236 (MCL 600.2167).

The committee recommends that this legislation be deferred until the January meeting.

Mr. Einhorn spoke about the Secretary of State's response to the to the State Bar's request for an interpretive ruling, her issuance of disclosure rules, and the legislative response to the Secretary of State's proposed rules.

Ms. Welch reported the results of the July Bar Examination to the Board. She reported that it is anticipated that Dean Joan Howarth from MSU Law School, will attend and speak with the Board at its January 17, 2014 meeting. Justice Brian Zahra has indicated an interest in attending and being part of that conversation.

Ms. Welch spoke about the decrease in the applicants applying for admission to law schools nationally, including in Michigan.
